As part of this commitment, we are aligned and in constant compliance with the provisions of the General Data Protection Law in Brazil (LGPD) - Law No. 13.709/18, and this notice is part of our governance program, intended for individuals who navigate our institutional page.

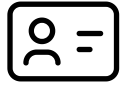

1. COLLECTION AND USE OF PERSONAL DATA ON THE WEBSITE

During your navigation, the personal data we collect on our website are those you voluntarily provide to us when contacting us through the email channel provided in the "Contact" and "Become a Partner" tabs.

These data are collected at the minimum necessary to respond to your messages, provide requested information about our products and services, and offer the best possible assistance.

The collection and use of personal data occur for this exclusive purpose, which is based on your consent, collected before sending us a message.

2. STORAGE AND SECURITY

The personal data under the responsibility of Apidouro are securely stored and accessed only by authorized members of our team who need this information to respond to your contact. We have implemented and monitor rigorous security measures to protect data from unauthorized access, loss, accidental situations, or any unauthorized alterations. If our contact is limited to email exchanges, the data will be stored for a maximum of 2 years. This period may be extended in the event of contract closure, in which case the processing of your data will have a different justification.

The storage of data occurs exclusively on our own server or on servers of third parties contracted for this purpose. Data disposal or anonymization will occur when they are no longer needed or in the event of revocation of the provided consent, with only the necessary data retained, if required, for legal compliance or the regular exercise of the controller's rights.

3. SHARING OF PERSONAL DATA

We do not share your personal data with third parties; your information is accessed exclusively by our internal team for direct communication and is not disclosed to other companies, organizations, or individuals.



4. COOKIES

Cookies are small pieces of information that your browser installs on your computer or mobile device, not necessarily being personal data, as they do not store or collect information. However, when a cookie is read by a server, it can assist a website or application in providing a personalized service.

Apidouro's website does not collect cookies, but we want to inform you, as a good practice, about this collection, and within your browser, you can at any time delete or disable all cookies within the settings, except for essential cookies that are necessary for the operation of a site that uses them.

5. YOUR RIGHTS AS A DATA SUBJECT

As a data subject, you have rights regarding your personal data, including the right to access the data we collect, correct incomplete or outdated data, request data deletion, and revoke consent at any time.
